## **NOTIFICATION**

## It is notified for the information of all concerned that:

- 1. The interview of candidates having qualified both Shorthand & Transcription tests for the post of PA to Hon'ble Judges, PA to Registrars & Personal Clerk to Deputy Registrar, pursuant to Notification No.56/2018 dated 04.04.2018, shall be conducted on 05.07.2018 & 06.07.2018 at Meeting Hall, Library Annexe Building, Madras High Court, Chennai 600 104 at 10A.M. as per the list containing the full particulars of the candidate(s), annexed herewith.
- 2. Mere figuring of name in the list does not entitle the candidate(s) to appear in the interview as it shall be subject to the scrutiny of all testimonials of the candidates shortlisted.
- 3. No individual interview call letter shall be sent by post to any candidate whose name figures in the said list and the candidate(s) shall have to download their call letter from their respective e-mails mentioned in the application and appear before the interview committee on the scheduled date and time. Failure of a candidate to appear for the interview on the given date and time shall forfeit his/her right of consideration.
- 4. In case any deficiency with reference to eligibility etc., is found at the time of interview, the candidate concerned shall not be allowed to appear in the interview, and if any deficiency is found subsequently, the candidate concerned shall not be considered for selection and he/she shall be treated as disqualified.
- 5. The candidates shall have to produce all original certificates/testimonials before the selection committee at the time of interview. A candidate who fails to produce such certificates / testimonials may forfeit his/her candidature.
- 6. Any candidate found guilty of impersonation or submits fabricated/ tampered documents/testimonials or makes false/incorrect statement or suppresses material information shall render himself/herself liable for criminal prosecution under law apart from forfeiture of his/her candidature.
- 7. All the candidates are required to bring along with them any photo ID like Adhaar Card, Voter ID, Driving License, PAN card etc. as a proof of their identity.
- 8. No TA/DA shall be paid for participation in the interview.
  - Note: a) The candidates have been included in the interview list provisionally and only such candidates shall be allowed to appear in the interview who fulfill all the notified eligibility requirements.
    - b) Mobile phones shall not be allowed in the office premises.
